WHO WE ARE

Rashtriya Samajik Utthan Parishad (RSUP) is an India based not-for-profit/non-Governmental grassroot organization, registered under charitable and religious trust act, 1920 with its registered office at **Sonbhadra, Arwal, Bihar, India**. RSUP started as a Community Based Organization in the year of 2015 and officially registered as a public trust on 07th June, 2016 was due to increased quest for services by the different target communities. RSUP works towards building sustainable community development avenues to improving services in healthcare, education, agriculture, animal husbandry, environment protection, women empowerment, Water-Sanitation & Hygiene (WaSH), child development, disaster management, livelihoods, social awareness and social welfare for the Indian communities, groups and persons.

Our activities revolve around awareness creation amalgamated with information dissemination, mobilization and sensitization of communities and individuals, distribution of IEC materials, Sustainable Community Asset building, Capacity Strengthening /Training and technical advice for entrepreneurship and gender mainstreaming with resultant benefits to the target audiences. Since its inception, RSUP has done projects on Rural Healthcare, Education, WaSH, Agriculture, Skill Development, Advocacy, Disaster and Child Survival. Different projects are being rolled out in different villages and blocks in **Arwal, Jehanabad, Gaya, Aurangabad, Bhagalpur and Kishanganj** Districts of Bihar based on community intervention needs. We have continued to expand in terms of capacity and turnover over the years.

RSUP'S strategy is to seek, work with and strengthen Community Development avenues that improve people's access to opportunities for improved livelihoods through their active participation. RSUP is governed by a five members Board of Trustees and a dedicated staff who ensure role out of different projects to meet stakeholders and target community expectations within the realm of project goals/objectives.

RSUP works closely with the Government Departments and Development agencies in rolling out of projects. We emphasize collaborations among stakeholders, Private Sector institutions, Statutory bodies, Civil Society organizations and devolving the same to the State, Districts and to local levels while promoting linkages between the levels.

Other than thematic agenda, RSUP Trust has been also working on Micro Credit Issue and mobilizing the communities' member (SHG) towards marketing and development of micro enterprise units and business development agenda.

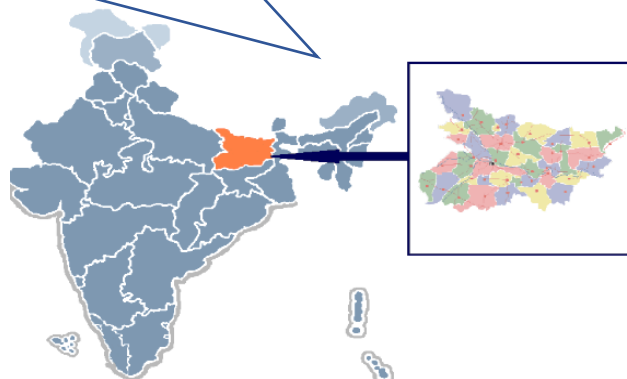
What We Do



Under the segment SD, RSUP runs and manages various programmes like Social Awareness, Religious and Spiritual Activities, Woman, Child and youth development, Natural Calamity relief and management, social entrepreneurship and livelihood, Social Welfare initiatives etc. that impact individual, community and society in general. RSUP also works on Micro Credit Issues and mobilizing the communities' members (SHG) towards marketing and development of micro enterprise units and business development agenda. When women earn, their income supports the whole family and saves for the future. Women in entrepreneurship is therefore an important factor in lifting households, more so the children from hunger and thus improve on their school attendance shaping their future. Poor women in rural settings do not benefit from loans given out by financial institutions because of lack of collaterals. Village/Group Savings and Loaning can offer a solution to enhance business start-ups to support families.

With over 50% of Bihar population identified as “multidimensionally poor”. Bihar has the maximum percentage of population living in poverty among all the States and the Union Territories, according to Government think-tank NITI Aayog’s Multidimensional Poverty Index (MPI).

As per the index, 51.91% of the population in Bihar is poor, followed by Jharkhand (42.16%), Uttar Pradesh (37.79%), Madhya Pradesh (36.65%) and Meghalaya (32.67%).

Education is a fundamental right, but given the sheer pressure on the public education system and the inability to afford expensive private education results in a huge number of children who drop out of education at an early stage. RSUP Trust understands the need and value of rural and semi urban education and sustainable livelihood-oriented training that make the society more informed and empowered.

So, in this segment, RSUP conducts various skill development programs and also runs low cost /free community learning centres/schools in remote rural areas of Bihar, India.

Vocational centres of the organization run sustainable livelihood training programmes in Computers, Beauty Care, Tailoring, Home Care Products making, Body Care Products making and many more for urban, semi urban and rural youths and women.

Female literacy rate of Bihar is just 60% means one of the least female literate states of India.

Important factors which affect the low literacy rate of women of rural Bihar

- ☞ Poor school environment for girls
- ☞ The lower enrolment due to family responsibilities
- ☞ Priority to son's education compared to daughter's education
- ☞ Poverty
- ☞ Early marriage & Dowry system
- ☞ Lack of adequate number of Female teachers

Healthcare and WaSH

Good and cost-effective healthcare and WaSH services are very big issues for rural and semi urban areas of India specially of Bihar. The underprivileged and poor societies, groups and individuals do not have proper access and awareness towards such healthcare and WaSH so RSUP India Trust works with other groups, foundations and organisations to identify communities or individuals who need help and organise assistance and awareness programs often involving trained medical professionals and community workers.

RSUPT also works on the WaSH (**Water, Sanitation and Hygiene**) initiative that has been taken by various countries in order to provide safe drinking water, proper sanitation facilities and a hygienic environment and livelihood to its people. This is a World Health Organisation (WHO) initiative considering the health and hygiene of people across the world.

Despite **COVID-19** putting the spotlight on the importance of hand hygiene to prevent the spread of disease, three billion people worldwide, including hundreds of millions of school-going children, do not have access to handwashing facilities with soap. People living in rural areas, urban slums, disaster-prone areas and low-income countries are the most vulnerable and the most affected.

The consequences of unsafe water, sanitation, and hygiene (WASH) on children can be deadly. Over 700 children under age 5 die every day of diarrhoeal diseases due to lack of appropriate WASH services. In areas of conflict, children are nearly 20 times more likely to die from diarrhoeal disease than from the conflict itself.

National Family Health Survey 2015-2016 (India) estimates that of the 336 million menstruating women in India about 121 million (roughly 36 percent) women are using sanitary napkins, locally or commercially produced.



PROGRAMMS & IMPACT

Key Facts

- Worldwide, 2.2 billion people still lack access to safe drinking water.
- More than half of the global population does not have access to safe sanitation.
- Three billion people do not have access to handwashing facilities with soap.
- Still, 673 million people practice open defecation.

OUTREACH PROGRAMME

While our healthcare and hygiene services have been focusing on curative care, our outreach programme addresses the need for preventative care. With trained 'Rural Healthcare Practitioners' (RHPs), we have started conducting door-to-door tests and screenings for early detection of kidney problems, hypertension, diabetes, vision problems, oral problems and malnutrition among the rural communities.

Woman Health & Hygiene

Agriculture & Environment

While more than 60% of India's population is directly dependent on agriculture, its contribution to the country's GDP is only 20%, indicating overdependence, unemployment and underemployment in the sector. With more than half the country's populations' direct dependence on this sector, we believe that there is a need to bring paradigm shift towards agriculture and its numerous tangible and intangible benefits.

RSUP'S farm activities include dairy, goat rearing, fishing and poultry. Dairy is introduced to develop an ecosystem around dairy farming and promote dairy as a sustainable livelihood option, which creates a steady revenue stream throughout the year for households.

RSUPT in association with other Govt. Organizations and private firms conducted/ conducts farmer training program on various needs. For the good agriculture outputs, organization conducts soil and water testing programs that includes farmers training camps too.

Today the environment remains a big issue for the whole world. The speed at which trees are being cut and ground water is being used is a dangerous sign. RSUP Trust took these environmental issues seriously and started plantation and environment protection social awareness program in Arwal, Jehanabad and Gaya districts of Bihar.

Bihar is one of the strongest agricultural states in the country. The percentage of population employed in agricultural production in Bihar is around 80%, which is much higher than the national average. It is the fourth largest producer of vegetables and the eight largest producers of fruits in India.

Still the cultivators of Bihar are in more stress and it is declining by 13% decade after decade. On the other hand, the number of agricultural and other laborers is increasing.
